Lyndel Prott is an Honorary Fellow of the Australian Academy of Humanities, LL.D. (honoris causa) B.A. LL.B. (University of Sydney) and holds a Licence spéciale en Droit international (ULB Brussels), the degree of Dr. Juris (Tübingen) and is member of Gray's Inn, London. She is former Director of UNESCO's Division of Cultural Heritage and former Professor of Cultural Heritage Law at the University of Sydney. She has had a distinguished career in teaching, research and practice. At UNESCO 1990-2002 she was responsible for the administration of UNESCO's cultural heritage Conventions and standard-setting Recommendations on the protection of cultural heritage and also for the negotiations of a number of UNESCO cultural heritage conventions.

Patrick J. O'Keefe BA, LLB (UQ), M.A. in Business Law (City of London Polytechnic), LL.M. (ANU), Ph.D. (University of Sydney). After moving to Paris in 1990, he spent 12 years as a consultant on cultural and natural heritage law and management to, among others, UNESCO, the Council of Europe, the World Bank, the Commonwealth Secretariat, ICOM and ICOMOS and various governments and private clients. He is a Fellow of the Society of Antiquaries of London; the Society of Advanced Legal Studies London; the Australian Academy of the Humanities and an Associate Fellow of the Institute for Indigenous Resource Management in Denver. He was the Founding Chairman of the Cultural Heritage Law Committee of the International Law Association and held the position for 14 years.
